## **CORRECTION OF DENIED GNOCHC CLAIMS**

GNOCHC providers may correct and resubmit denied GNOCHC claims, as follows. **Providers are strongly encouraged to resubmit corrected claims as soon as possible.** The earlier a correction is resubmitted, the longer the timeframe a provider will have to make subsequent corrections should the original correction be denied.

### **Demonstration Year 1 Claims**

#### **CLAIMS SUBMITTED TO MOLINA ON FORM CMS-1500**

Denied claims for GNOCHC encounters with dates of service October 1, 2010 through September 30, 2011 submitted to Molina in paper or electronic CMS-1500 format by November 14, 2011 may be corrected and resubmitted in paper CMS-1500 format **only**.

Corrected claims **must** be submitted with a copy of the Remittance Advice documenting the submission of the denied claim by the November 14, 2011 deadline. For each resubmitted claim, the line(s) of the RA referencing the denied claim **must** be highlighted in yellow, and the RA must immediately follow the corrected Form CMS-1500. Do not staple the Form CMS-1500 to the RA.

Package all corrected claims in a 9 x 12 brown envelope labeled "GNOCHC" in **large bold print**, and mail the envelope(s) to the address below.

Corrected claims for Demonstration Year 1 must be received by Molina not later than **February 8, 2012**. Corrected claims for Demonstration Year 1 received by Molina after February 8, 2012 will be returned unprocessed to the provider with a rejection letter listing untimely filing as the reason the claims are being returned. **Postmark dates will not be considered.**

#### **CLAIMS SUBMITTED TO DHH ON FORM GNOCHC-1**

Denied claims for GNOCHC encounters with dates of service October 1, 2010 through September 30, 2011 submitted to DHH on Form GNOCHC-1 by November 14, 2011 may be corrected and resubmitted on Form GNOCHC-1 only.

Corrected claims must be submitted to [GNOCHC@la.gov](mailto:GNOCHC@la.gov) not later than **February 8, 2012**. Corrected claims for Demonstration Year 1 received by DHH after February 8, 2012 will be returned unprocessed to the provider with a rejection letter listing untimely filing as the reason the claims are being returned.

### **Demonstration Year 2 Claims**

Denied claims for GNOCHC encounters with dates of service October 1, 2011 through September 30, 2012 may be corrected and resubmitted to Molina in paper or electronic CMS-1500 format. Corrected claims for GNOCHC encounters with dates of service October 1, 2011 through September 30, 2012 must be resubmitted to Molina within 12 months of the date of service but may not be submitted later than November 14, 2012.
