CONCURRENT SERVICES

Waiver services that are available while a beneficiary is in a hospital or in a nursing facility are considered concurrent services. Some Community Choices Waiver (CCW) services are payable when a beneficiary is in a hospital or nursing facility. All services must be prior approved as indicated in Section 7.1 – Covered Services.

The following CCW services are payable when a beneficiary who has been receiving CCW services has a temporary stay in a hospital or a nursing facility or when a beneficiary is transitioning from a nursing facility to the community:
